



INSTRUCTIONS FOR COMPLETION OF SUBSCRIPTION DOCUMENTS

Each Subscriber for the Notes of and/or Member Interest (Equity) in SUNCOAST PROFESSIONAL CENTER, LLC should complete the Note and Member Interest Subscription Agreement as follows:

1. In the top right corner of the first page, print the name(s) of the person(s) or entity subscribing for a Note and/or Member Interest (Equity). If you are subscribing for Notes and/or Member Interest (Equity) to be held or owned by more than one person (unless a married couple) or more than one entity, you must fill out and submit a separate Subscription Agreement for each subscribing person and entity.
2. On the Signature Page (page 12), complete all of the following:
 - a. Print and sign your name(s) on the signature lines at the top right of the page;
 - b. Insert your social security number(s) or federal employer identification number and the date of your execution of the Subscription Agreement on the first two lines at the top left of the page;
 - c. Complete your address, phone number, fax and e-mail information on the lines indicated for same on the right side of the page;
 - d. If you are subscribing for Notes, fill in the dollar amount of the Notes you are subscribing for under the heading "Subscription Amount - Class A Note: \$ _____" on the left side of the page;
 - e. If you are subscribing for Member Interest, fill in the dollar amount of Member Interests you are subscribing for under the heading "Subscription Amount - Class B Equity: \$ _____" on the left side of the page; and
 - f. Check the appropriate blank at the left of the page indicating the manner in which the Notes and/or Member Interest you are subscribing for are to be held (i.e. Tenants in Common, Husband & Wife as Joint Tenants with Right of Survivorship, Joint Tenants, Corporation, IRA, etc).
 - g. Check the appropriate blank(s) at the bottom of the page, under "Accredited Investor Status," which properly indicates your status as an Accredited Investor.

3. Note that each person or entity subscribing for Notes and/or Member Interests (Equity) must complete and submit a Subscription Agreement and corresponding documents. Please note that if the subscription is by a married couple as Tenants in Common or Joint Tenants, only one Subscription Agreement and one set of documents need be filled out with the names, social security numbers and signatures of both spouses. If you need an additional Subscription Agreement and other documents, please call Nelly Rodriguez at (954) 515-0039

4. You may submit the funds for your subscription in a single amount, even if you are subscribing for both Notes and Member Interest. You may pay by check or by wire transfer.

5. If you are subscribing for Member Interest (Equity), each subscriber must ALSO sign the Operating Agreement on page 49 and print your social security number or federal tax identification number. You need only return the original signed Signature Page, not the entire agreement.
